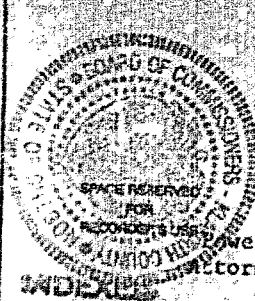

KNOW ALL BY THESE PRESENTS that I, Charlene Nichols

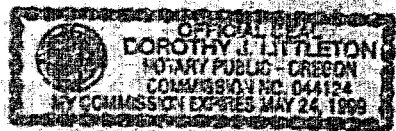
