THOMAS W. McFARLANE, of legal age, being first duly sworn, deposes and says:

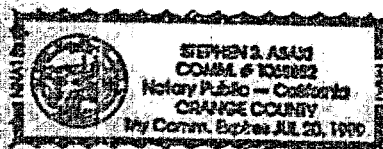
