KNOW ALL MEN BY THESE PRESENTS, That

James Douglas Murdoch & Mary Anice Murdoch, husband & wife, hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and quitclaim unto The James D. Murdoch & Mary A. Murdoch Family Trust under instrument dated September 28, 1990 hereinafter called grantee and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any-wise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A parcel of land situated in Lot 2, Sec. 35, Twp. 40 S., Range 10E., W.M., containing 5.14 acres, more or less; more particularly described as follows: Beginning at a 5/8" iron rod on the Southwesterly right-of-way boundary of the Great Northern Railroad from which the Section corner common to Sections 34, 35, 2 and 3 bears S. 40 deg. 30' W. 1685.35 feet; thence S. 69 deg. 22' 54" W. 731.17 feet to a 1/8" iron rod on which the high left bank of Lost River; thence continuing along said bearing 60 feet, more or less, to the water's edge of Lost River; thence upstream along the left bank of Lost River to a point from which a 5/8" iron rod on the high left bank of Lost River bears N. 53 deg. 49' E. 60 feet, more or less; thence N. 53 deg. 49' E. 661.81 feet to a 5/8" iron rod on the Southwesterly right-of-way boundary of the Great Northern Railroad; thence South 28 deg. 43' 04" E. 551.45 feet along the Southwesterly right-of-way boundary of the Great Northern Railroad, to the place of beginning; SUBJECT TO: (1) Regulations, including levies, assessments, water and irrigation rights and easements for ditches and canals, of Klamath Irrigation District; (2) Rights of the public in and to any portion of said premises lying within the limits of roads and highways; (3) Rights of the public and of governmental bodies in that portion of the above described property lying below the high water mark of Lost River and the ownership of the State of Oregon in that portion lying below the high water thereof; and (4) the 1973-74 taxes.

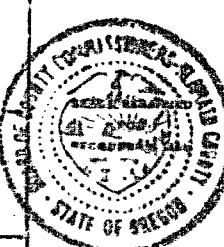
