- c The applicant agrees to file a deed restriction and to not further divide the property nor to build or allow to be built more than one house on the property.
- There does appear to be adequate services to the area.

3 ORDER

Therefore, it is hereby ordered that the applicants request to rezone the area from R-5 to R-1 is approved conditionally

The applicant shall file a deed restriction within 15 days of this order on the parcel which limits the number of homes which may ever be constructed on this parcel to one and prohibits any subdivision of the parcel

Even though it is technically R1 zoning due to these restrictions the intent is to effectively limit this to a R 3.63 zoning.

The applicant shall send a copy of the deed restriction to the gepartment within 20 days of this order.

Neither the applicant nor their successors in interast shall construct more than one dwelling on the parcel and the parcel shall not be subdivided at any time in the future.
