FINAL ORDER

JOHN SALMONS AKA JOHN MATHIS A+ CARPET CLEANING **1735 DERBY** KLAMATH FALLS OR 97603

On January 6, 1997, the board properly served notice on John Salmons aka John Mathis dba A+ Carpet Cleaning (hereinafter SALMONS) that it intended to issue a civil penalty in the amount of \$5,700 for violation of ORS 701.055(1) and OAR 812-003-0000(7). The Notice further granted to SALMONS an opportunity for hearing, if requested within 21 days. A hearing was requested on January 15, 1997, and a hearing was set for June 12, 1997. At the hearing, a settlement agreement was made.

FINDINGS OF FACT

- 1. On or about October 26, 1996, SALMONS did not have an active registration with the Construction Contractors Board SALMONS registration, number 90514, expired May 3, 1994.
- 2. On or about October 26,1 996, SALMONS contracted with Philip Macomber Jr. to clean carpets in five rooms at 4712 Villa Drive, Klamath Falls, Oregon. SALMONS attempted to repair the carpet which resulted in swirl marks and drip marks and stained furniture from the bleaching process.
- 3. At the hearing, a settlement was reached in which it was agreed that the CCB would not pursue allegations that SALMONS had worked as a contractor while using an invalid registration and would not seek a \$5,000 penalty based on those allegations, in return for which SALMONS would agree that he had engaged in advertising as a contractor using an invalid registration number and would pay a civil penalty of \$700 for that violation.

ULTIMATE FINDINGS OF FACT

SALMONS violated OAR 812-003-0000(7) by advertising as a contractor on or about October 26, 1997.

ORDER

It is ordered that Salmons pay a civil penalty in the amount of \$700.
