## TRUSTEE'S DEED

THIS INDENTURE, Made this date, April 7, 1999, between Glenn H. Prohaska. hereinafter called trustee, and First Bank National Association, hereinafter called the second party; WITNESSETH: RECITALS: Diler E. Catterton and Margaret Catterton, as grantor, executed and delivered to Bonnie P.
