
Substitution of Trustee



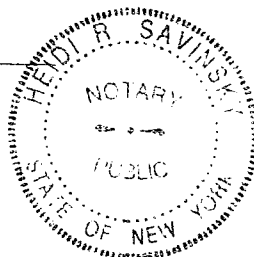
