- c. The applicant failed to appear and offer testimony to rebut the testimony of others who did attend the hearing.
- d. There was significant concern raised about the drainage in the area.
- e. The area proposed to locate this second dwelling is not appropriate for a structure of any kind

Therefore, it is hereby ordered that the applicants request to install a mobile home is denied.
