RECITALS

A. Running Y Ranch Resort consists of certain real property ("Property") located in the County of Klamath, State of Oregon. The "Property", known as Running Y Ranch Resort, within Klamath County, Oregon, is subject to that certain Declaration of Protective Covenants, Conditions, Restrictions and Easements for Running Y Ranch Resort, dated August 2, 1996, and recorded August 2, 1996, in Volume M96, Page 23548, Official Records of Klamath County Recorder (hereinafter referred to as the "Declaration"). Each of the definitions contained in the Declaration are hereby adopted by reference.

B.
