by the Water Resources Department. Most uses of water require a water right issued by the Water Resources Department. However, state law allows some uses of groundwate: without benefit of a water right. Contact the Department for more information. The Water Resources Department cannot guarantee the presence of water in the desired amount on a specific property.

In addition to the above, owners of properties on which a well is located are responsible for maintaining that well in a proper manner. Some basic requirements are listed belo v:

- All wells shall be maintained in a condition where they are not a threat to public health or safety, a source of contamination, or a waste of the groundwater
- All wells shall be securely covered to prevent any foreign substance from entering the well.
- All wells shall be equipped with an access port or airline so that static water level information can be determined at any time.
- Well casing must be protected from damage and meet minimum extension requirements.
- Well's may only be permanently abandoned by a licensed and bonded well constructor or a landowner with a valid permit and bond. Well abandonment mus, be carried out in accordance with state rules.
