KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated March 19, 1996, executed and delivered by Ronald H. Kroop & Kathy L. 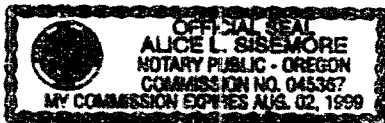
