

Therefore, it is hereby ordered that the applicants request to develop a pre-1976 Mobilhome is approved subject to the following conditions:

- a. That approval is obtained for on-site sewage disposal and that the applicant provides proof of clearance from the Environmental Health Services Division and Building department within two (2) years following the date of this order, or obtain an extension of time, or this approval will be void.
- b. That the applicant complies fully with fire safety and other siting standards of the Land Use Code as set out in Article 69 of the LDC.
- c. That the applicant receive approval for and develop an on-site well or other source of water consistent with LDC 55.06(C)(4).
- d. That applicant is directed to build a deck on the front of the home after it is installed to code and to landscape around it within 14 months of installation.
- e. The applicant is forbidden to occupy the location until the manufactured dwelling is approved for occupancy by the County Building Department and all conditions of this order have been met.
- f. That all required building and placement permits or an extension of time be obtained within two (2) years following the date of this order or this approval will be void.
