MEMORANDUM OF SUBLEASE

THIS MEMORANDUM OF SUBLEASE (this "Memorandum") is made as of 4-2-, 1999, by and between Sierra Cascade Nursery, Inc., a California corporation ("Sublessor"), and Driscoll Strawberry Associates, Inc., a California corporation ("Sublessee").

Recitals

- A. Sublessor has leased from Grant E. Brown and Lois M. 1. Sublessor hereby subleases the Premises to Sublessee, pursuant to the terms and conditions contained in the Sublease, for a term commencing on <u>Govl 2 1999</u> and expiring on December 31, 1999.

2. This Memorandum and the Sublease are governed by the laws of the State of California. This Memorandum shall not be construed as modifying the terms or conditions of the Sublease. In the event of a conflict between this Memorandum and the Sublease, the Sublease shall control. This Memorandum may be signed in counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same Memorandum.
