MEMORANDUM OF SUBLEASE

THIS MEMORANDUM OF SUBLEASE (this "Memorandum") is made as of Arau 2, 1999, by and between Sierra Cascade Nursery, Inc., a California corporation ("Sublessor"), and Driscoll Strawberry Associates, Inc., a California corporation ("Sublessee").

Recitals

- A. Sublessor has leased from Raymond R. Colahan and Sharon Colahan, husband and wife, and Ross H. 
