KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated April 2, 1993; October 8, 1996, executed and delivered by Rodney S. 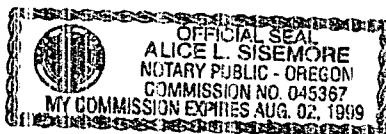
