

DESCRIPTION OF PROPERTY

The following described real property situate in Klamath County, Oregon

A portion of the E 1/2 NW 1/4 of Section 33, Township 39 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:
