The applicant has applied to establish a Church on one lot zoned RCR. This request was heard by the 1. NATURE OF THE REQUEST hearings officer May 21, 1999. The request was reviewed for conformance with Klamath County Land Development Code.

3. LOCATION OF PROPERTY

5. FINDINGS

The Hearings officer FINDS AS FOLLOWS:

- The development of this type of structure is not included in the permitted uses for this zoning, however the LDC permits a conditional use.
- b. The property owners were notified and did not object.
- c. The surrounding area is mixed residential and commercial
- d. There is adequate parking for the facility as designed e. There is no parking allowed on the street in this area or for the church.
- There is sufficient handicapped parking.

6. ORDER

Therefore, it is hereby ordered that the applicant's request to develop a template forest dwelling is

- approved subject to the following conditions: a. That approval is obtained for on-site sewage disposal and that the applicant provides proof of clearance from the Environmental Health Services Division and Building department before
- b. That this permit shall only allow the currently designed number of seats as shown in the
- c. That the applicant will submit a photograph showing that the landscaping and parking areas are complete within 4 months of occupancy or this permit shall be void.
- d. That there shall be no parking for this facility on Manzinita and that the applicant will take any necessary steps to insure that people using the facility do not park on the street.

That all required building and placement permits or an extension of time be obtained within two
 (2) years following the date of this order or this approval will be void.
