QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that *Carl D. McFall* on this *28th* day of *July*, 19*98* hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto *The Carl D. McFall Trust* hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in *Klamath* County, State of Oregon, described as follows, to-wit:

A tract of Land situated in the SW1/4 of Section 7 Township 38 South, Range 9 of the Willamette Meridian, Klamath County, Oregon described as follows:

Beginning at a point which bears North 24 degrees 52' West a distance of 39 feet and then North 89 degrees 09' West a distance of 272.1 feet from the iron pin which marks the quarter section corner common to sections 7 and 18, Township 38 South, Range 9 East of the Willamette Meridian, and running thence: Continuing North 89 degrees 09' West a distance of 124 feet to a point; thence North 0 degrees 55' East a distance of 314.6 Feet to a point; thence North 59 degrees 53' East a distance of 143.5 feet to a point; thence South 0 degrees 55' West a distance of 388.6 Feet, more or less, to the point of beginning.

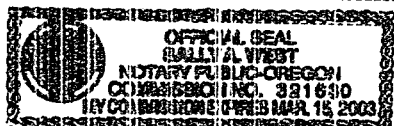
