

DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated <u>July 15, 1998</u>, executed and delivered by <u>Darryl D. Baeth & Joanne</u> <u>M.
