That Portion of Tract 5 of SUBDIVISION OF TRACTS 25 TO 32, inclusive, TOGETHER WITH THE SOUTH IN FEET OF TRACTS 33 and 34 of ALTAMONT RANCH TRACTS, according to the official plat thereof on file in the office of

Any contract, obligation or indebtedness incurred or entered into by the Trustee in connection with said property shall be as Trustee of an Express Trust and not Individually and theTrustee shall have no obligation whatsover with respect to any Contract, obligation or indebtedness except only so far as the trust property in the actual possession of the thereof; and it shall be expressly understood that any representattions, covenants, undertakings and agreements hereinafter made on the part of the Trustee, while in form purporting to be the representations, warranties, covenants, undertakings and agreements by the Trustee, are nevertheless made and intended not as personal representations, warranties, covenants, undertakings and agreements Trustee or for the purpose or with the intention of binding said Trustee personally, but Trustee or for the purpose or with the intention or pinding said irustee personally, but are made and intended for the purpose of binding only the trust property specifically described herein, and that no personal liability or personal responsibility is assumed by nor shall at any time be asserted or enforceable against the trustee individually or on account of wany instrument executed by or on account of any representations, warranty, covenant, undertaking or agreement of the Trustee, either expressed or implied; All such personal liability, if any, expressly waived and released & all persons, corporations and other being all persons, corporations and other legal entities whomsoever and whatsoever shall be charged with notice of this condition from the date of the filing for record of this Deed.

In no case shall any party dealing with said Trustee in relation to said property, or to whom said property or any part thereof shall be conveyed, contracted to be sold, leased or mortgaged by said Trustee, be obliged to see to the application of any purchase money, rent or money borrowed or advanced on said property, or be obliged to see that the terms of this trust have been complied with, or be obliged to inquire into the necessity or expediency of any act of said Trustee, or be obliged or privileged to inquire into any of the terms of said trust agreement, and every deed, trust deed, mortgage, lease or other instrument executed by said Trustee in relation to said property shall be conclusive lease or other instrument (a) that at the time of the deliver thereof the trust created by this indenture and by said Trust Agreement was in full force and effect, (b) that such the Trustee was duly authorized and empowered to execute and deliver every such deed, to a successor or successors in trust, that such are fully vested with all the title estate, rights, powers, authorities, duties and obligations of its, his, her or their predessor in trust.
