### NATURE OF THE REQUEST

The applicant, has applied for a permit install a mobile home. This request was heard by the hearings officer May 7 and again May 21, 1999 and again June 7. The request was reviewed for conformance with Klamath County Land Development Code.

## 4. MATERIALS CONSIDERED

All evidence submitted by the applicant and located in the Staff Report was considered as was the oral testimony given at the hearing by the department.

#### 5. FINDINGS

The Hearings officer FINDS AS FOLLOWS:

- a. The development of this type of structure is not included in the permitted uses for this zoning but may be approved conditionally under some circumstances.
- b. That the applicant had the home in Klamath County before February of 1999.
- c. That the applicant will be remodeling the structure so that it is appropriate for the area.
- d. That the applicant will provide proof to the county before construction begins that the unit is in substantial compliance with current building codes as per

#### 6. ORDER

Therefore, it is hereby ordered that the applicants request to install a mobile home is approved subject to the following conditions.

- a. The unit will be placed on a foundation of support system approved by the building officals and
- b. The unit shall be certified as "substantially equivalent" to the HUD certifications under 84.010( C)(2).

- c. The utilities shall be connected in accordance with the building department and manufacturers specifications.
- d. The improvements shown on Exhibits F and E shall be complete by July 1, 2000.
- e. The applicant shall file photographic proof of the completion of the above by August 1, 2000.
- f. All placement permits, septic work and the like shall be completed by July 1, 2000.

g. If the above conditions are not met this permit is void.
