

ORS 114.545(3) requires that an offiant's or claiming successor's deed executed in the manner required by ORS Chapter 93 be recorded in the deed records of any county in which rest property belonging to the decedent is situated.

EXCERPT FROM ORS 114.815: "If the details consists of personal property having a fair market value of \$50,000 or less, or real property having a fair market value of \$50,000 or less, or real property having a fair market value of \$50,000 or less, not loss than 30 days after the death of the decedent, one or more of the claiming successors may file an affidavit with the clork of the probate court in any county where there is venue for a proceeding seeking the appointment of a personal representative for the estate. The affidavit shell contain the information required by ORS 114.525\*\*\*
