WHEREAS, an oversight occurred in the Klamath County Assessor's office when only one parcel was changed into Roylene D. Unive with a different address; and

WHEREAS, the above parcel was signed into Judgment and Decree on January 27, 1995, for delinquent taxes and interest, and the last one year redemption notices were mailed on March 3, 1997, to Ramon Leo Unive and Roylene Benson who also appears of record as Roylene D. Unive at the address when both parties had an interest in the property. The redemption period expired and the above parcel was deeded to Klamath County on December 2, 1998; and

WHEREAS, the above parcel is being offered for sale at a June 17, 1999, public sale and should be removed since the last one year redemption notice was mailed to an incorrect address.

NOW THEREFORE, it is ordered that the above described parcel is removed from the June 17, 1999, public sale, and the foreclosure deed recorded in Volume M98, Page 43929.
