

MEMORANDUM OF LAND SALE AGREEMENT

In Witness Whereof the said vendor has executed this Memorandum July 1, 1999.

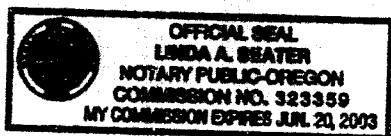
