SUBJECT TO Covenants, conditions, reservations, easements, restrictions, rights, rights of way and all matters appearing of record.

The true and actual consideration of the transfer, set forth in said Land Sale Agreement is \$2,800.00, all deferred payments bear interest at the rate of 10% per annum from the date of said Land Sale Agreement until paid.

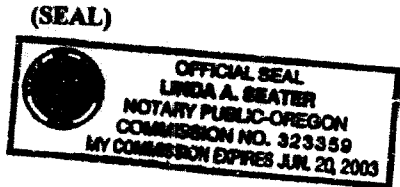
