ORDER MODIFYING DECREE

THIS MATTER having come before the Court upon the Motion of Respondent,

Bryan James Shults, to modify the Decree entered herein on April 15, 1997, by
terminating spousal support and by modifying child support to a reasonable amount
according to the parties' current income, for the reason that Respondent has had a
substantial reduction in income; the parties having been present personally and by and
through Jeffrey W. Foxx, attorney for Respondent, William H. Fowler of attorneys for

1 Petitioner, and Ruben D. Rudolph, Deputy District Attorney, representing the Family
2 Support Division; and the Court having received evidence and testimony of the parties
3 and having received the stipulation of Petitioner that Respondent's Motion to terminate
4 spousal support was not contested, and the Court being fully advised and good cause
5 appearing therefor, It Is Hereby
6

7 **ORDERED**, that the Decree entered in this case on April 15, 1997 be, and the
8 same is, modified as follows:

9 1. That spousal support set forth in paragraph 8 of the Decree is
10 terminated, effective February 28, 1999.

11 2. That child support set forth in paragraph 4 of the Decree shall be
12 modified as follows: Respondent, Bryan James Shults, shall pay to Petitioner as and
13 for the support and maintenance of each of his minor children, namely: DANIELLE
14 KRISTINE SHULTS and DERIC BRYAN SHULTS, the sum of Three Hundred Eighty
15 Nine and eighty/100ths (\$389.80) Dollars per month, for a total support obligation of
16 Seven Hundred Seventy Nine and sixty/100ths (\$779.60) Dollars, with the first such
17 payment being due and payable on the 5th day of March, 1999, with a like payment
18 due on the same day of each month thereafter during the minority of each of said
19 children, and thereafter, for each child, so long as the child is attending school as
20 defined in ORS 107.108. That this Order is based upon Computation Worksheet B
