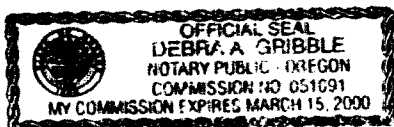

NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by GLORIA J. FORE, as grantor, to AMERITI, as trustee, in favor of HARRY AL.
