

**MEMORANDUM OF LAND SALE AGREEMENT**

In Witness Whereof the said vendor has executed this Memorandum July 7, 1999.

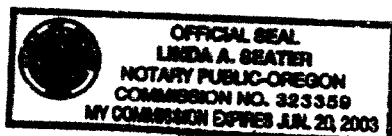
