In Witness Whereof the said vendor has executed this Memorandum July 8, 1999.

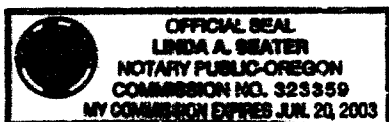
