MORE COMMONLY KNOWN AS: 10690 MCGUIRE AVENUE, KLAMATH FALLS, OR 97603.



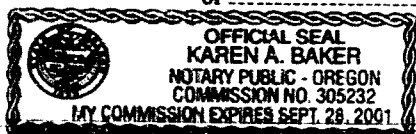
