UTILITY EASEMENT AGREEMENT

A PERMANENT EASEMENT, PERPETUAL, AND EXCLUSIVE RIGHT OF WAY, INCLUDING RIGHT TO ENTER UPON THE REAL ESTATE HEREIN AFTER DESCRIBED, AT ANY TIME THAT IT MAY SEE FIT, AND CONSTRUCT, MAINTAIN, AND REPAIR UNDER GROUND PIPELINES AND OR MAINS FOR THE PURPOSE OF CONVEYING WATER OVER, ACROSS, THROUGH, AND UNDER THE LANDS HEREINAFTER DESCRIBED, TOGETHER WITH THE RIGHT TO EXCAVATE AND REFILL DITCHES AND OR TRENCHES FOR THE LOCATION OF SAID PIPELINES AND OR MAINS, AND FURTHER RIGHT TO REMOVE TREES, BUSHES, UNDERGROWTH, AND OTHER OBSTRUCTIONS INTERFERING WITH THE LOCATION, CONSTRUCTION, AND MAINTENANCE OF SAID PIPELINES AND OR MAINS.

THE LAND AFFECTED BY THE GRANT OF THIS EASEMENT AND RIGHT OF WAY IS LOCATED IN KLAMATH COUNTY, STATE OF GREGON, LOCATED ON ASSESSMENT MAP 24 09 30DB AND MORE PARTICULARLY DESCRIBE AS FOLLOWS:

Commencing at a point on Potter and Sixth Street in Northwest one quarter of Southeast one quarter of Section 30 township 24 South Range 9 East W.M. at the Southeast corner of Tax lot 200, Lot 1 Thirty (30) feet wide, west of and parallel to the Western edge of vacated on 10-13-1972 Sixth Street and also described as the East line of Tax Lot 200 (lots 1, 2, 3, 4, 5) and in a Northeasterly manner to the end of vacated street.
