You shall not be required to remedy any such injury or compensate me therefor. I shall cooperate in all respects in the performance of the audit. I shall pay the costs of the audit if either a default exists under this Deed of Trust at the time you arrange to have the audit performed or if the audit reveals a default perfaming to hazardous substances. If I refuse to permit you or you representatives to conduct an environmental audit on the Property, you may specifically enforce performance of this provision. 8.3 You and your representatives may enter the Property at any provision.
