MEMORANDUM OF DISTRIBUTIONS

Virginia M. Drew and David S. Drew, the acting General Trustees of the Frank and Virginia Drew Restated 1983 Trust uda 8/4/97 Bypass Trust effective 10/9/97, hereby declare that the herein described real property situate in Klamath County, Oregon, has been allocated by the Special Trustee of said Trust to said Trust's Bypass Share and is now part of its Bypass Trust:

Parcel 1: A piece or parcel of land in the NW¼ of Section 3, Township 39 South, Range 9 East of the Willamette Meridian, more particularly described as follows: Commencing at the section corner marking the Northwest corner of the said Section 3, Township 39 South, Range 9 East of the Willamette Meridian, and running thence South 0°00½' East along the Westerly boundary of the said Section 3, 826.8 feet, more or less, to its intersection with a line parallel with and 75.0 feet distant at right angles Northeasterly from the center line of the Dalles-California Highway, also known as South Sixth Street, as the same is now located and constructed; thence South 55°52½' East, along said parallel line 1166.2 feet to the true point of beginning of this description; running thence South 55°52½' East along said parallel line 50 feet; thence North 34°07½' East 175.0 feet; thence North 55°52½' West along a line parallel with said highway center line 50 feet; thence South 34°07½' West 175.0 feet, to the said point of beginning. Parcel 2: The Easterly 20 feet of the Southerly 105 feet of Lot 3, Block 15, of the Original Town of Linkville, now the City of Klamath Falls, Klamath County, Oregon. [619 Main Street. Assessor's #R3809-032AB-05800-000.]

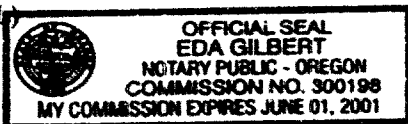
