DESCRIPTION

The following described real property situate in Klamath County, Oregon:

A parcel of land located in the SE ½ SW ½ of Section 7, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at an iron pipe marking the quarter corner common to sections 7 and 18, Township and Range aforesaid, thence North 89°42' West a distance of 770.8 feet; thence North 6°02' East a distance of 290.9 feet to a point on the Westerly right of way line of the Dalles California Highway, known as Wocus Road, a County Road, which point is at the Southeast corner of the tract herein described; thence North 6°02' East a distance of 112.1 feet; thence North 89°42' West a distance of 591.8 feet; thence South 0°01' West a distance of 111.5 feet; thence South 89°42' East a distance of 580 feet to the point of beginning, EXCEPTING portion conveyed to the State of Oregon, by and through its State Highway Commission by deed recorded on Page 65, Volume 138, Deed records of Klamath County, Oregon.
