The lien hereby claimed is for materials furnished and delivered at said premises to be used, and which were used, in the construction, alteration and repair of said building, which materials were furnished by claimant to, and at the specific instance and request of STEVE BARROWS CONSTRUCTION.

At the time of commencing to furnish said materials, STEPHEN W. BARROWS was and still is the owner of said building and of said land, and the construction, alteration and repair of said building was commenced and carned on with the knowledge, approval and consent of the said STEPHEN W. BARROWS.

Said materials were furnished between the dates of July 22, 1998 and May 25, 1999. All unpaid invoices are listed on the attached EXHIBIT A, dating from May 12, 1999 through May 25, 1999. The contract and reasonable price thereof was, and is the sum of SIX THOUSAND SEVEN HUNDRED TWENTY DOLLARS AND 00/100 (\$6,720,00), less credits and offsets in the amount of TWO THOUSAND SIX DOLLARS AND 78/100 (\$2,006,78), leaving an amount due for the materials in the sum of FOUR THOUSAND SEVEN HUNDRED THIRTEEN DOLLARS AND 22/100 (\$4,713.22), plus late charges in the amount of ONE HUNDRED FOURTY ONE DOLLARS AND 40/100 (\$141.40), and plus FIFTEEN DOLLARS (\$15,00) to cover the cost of recording the lien; leaving a balance on account thereof now due to the claimant in the sum of FOUR THOUSAND EIGHT HUNDRED SIXTY NINE DOLLARS AND 62/100 (\$4,869,62).
