VIOLATION: A noncomplying employer is subject to a civil penalty as provided by ORS 656.735(3), (4), if a subject worker receives a compensable injury while in the employ of the noncomplying employer.

FINDINGS: On July 7, 1997, the Department issued an Order declaring DAVID G CLELLAND to be noncomplying from June 1, 1996 to June 17, 1997. The Order became final on December 8, 1997.

During the period the above-named employer was a Honcomplying Employer, a subject worker, Joseph L Cilione, on Hay 21, 1997, sustained a compensable injury; and such determination of compensable injury was final on April 29, 1999.
