DEED OF RECONVEYANCE

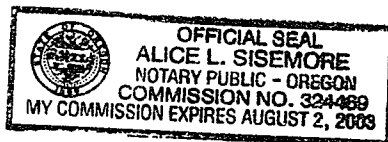
