COMMUNICATIONS LINE RIGHT-OF-WAY EASEMENT

DBA CENTURYTEL, its successors and assigns, (hereinafter referred to as the "Company"), the right to construct, operate and maintain buried and aerial telephone and communications facilities, together with all necessary wires, poles, down-guys, anchors and fixtures incidental thereto, under, upon, over and across the following described property:

A strip of land ten (10) feet in width, the centerline of said strip being contiguous to the centerline traverse of buried and aerial communications cables first placed after the date of this grant of easement in the the SE1/4SW1/4, the NW1/4SE1/4 and the W1/2NE1/4 Section 30, T.40S., R.12E., W.M., the locations of said buried and aerial communications cables being as generally shown on Exhibit "A", attached hereto and made part hereof.

situated in the County of Klamath, State of Oregon, together with such additional adjacent area as may be reasonably required by the Company for placement and maintenance of down-guys and anchors supporting the Company's telephone and communications facilities placed hereunder.

It is agreed that the Company, its successors and assigns, shall have access to said premises for the purposes stated, and shall be responsible for any damage to said premises by reason of any negligence on the part of said Company's employees while placing and maintaining construction, provided, however, that the Company shall have the right to clear and keep cleared trees or other obstructions which may interfere or threaten to interfere with the exercise of the Company's rights granted hereunder.

For and in consideration of the rights granted herein, the Company hereby quitclaims and releases to Grantors all rights granted to the Company in that Communications Line Right-of-Way Easement recorded August 3, 1999 in Volume M99 at Page 30993 of Klamath County Deed Records.
