

MEMORANDUM OF LAND SALE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that on August 20, 1999, **Klamath County**, a Political subdivision of the State of Oregon, as vendor and Larry Willis & Sharon R. In Witness Whereof the said vendor has executed this Memorandum September 13, 1999.

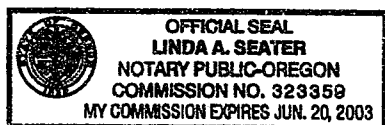
