- Grantee shall submit the as-built construction plans to the City's Public 21 Works Department and shall conform to any modifications or restrictions imposed by the Department.

Grantee agrees to pay to the City, as compensation for the privileges herein granted, the sum of Fifty Dollars (\$50.00), receipt of which is hereby acknowledged by

Grantee shall save and hold harmless the City from, and indemnify the City agains: any and all liability for or on account of any death or injury to persons, or damage property incurred in any manner whatsoever growing out of Grantee's use or the public s loss of the privileges herein granted.

This agreement shall run from year to year unless terminated. It may be terminated upon sixty (60) days written notice by either party. Upon termination, Grantee shall remove all structures herein authorized and restore the public right-of-way in accordance with the directions of the City's Director of Public Works within sixty (60) days.
