KNOW ALL BY THESE PRESENTS that Vicki S. Wickersham AS HIS SOLE AND SEPERATE PROPERTY hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

5411 Hwy. 66, Klamath Falls, Oregon:

A tract of land situate in the NW 1/4 of the NE 1/4 of section 13, Township 39 South, Range 8 East of the Willamette Meridian, in the County of Klamath, Sate of Oregon, and being more particularly described as follows:

Beginning at the North quarter corner of Section 13, Township 39 South, Range 8 East of the Willamette Meridian, according to the plat on file #231 in the Klamath County Surveyor's office; thence East along the Section line 1051.69 feet to the westerly right of way of State Highway #66, thence South 27 37' West along said right of way, 838.45 feet; thence North 62 23' West 80.1 feet to the true point of beginning of this description; thence North 62 23' West 119.45 feet; thence South 24 12' West 194.9 feet; thence South 52 07 1/2' East 109.68 feet; thence North 27 37' East 214.2 feet to the true point of beginning of this description.

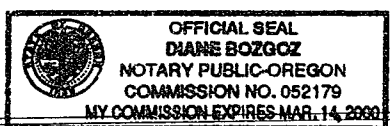
In construing this deed, where the context so requires, the singular includes the plural, and all grammatical changes shall be made so that this deed shall apply equally to corporations and to individuals.
