

In Witness Whereof the said vendor has executed this Memorandum September 28, 1999.

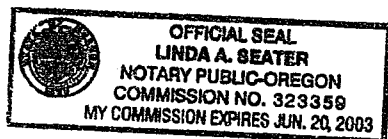


