QUITCLAIM DEED

UNION PACIFIC RAILROAD COMPANY, a Delaware corporation, Grantor, formerly known as Southern Pacific Transportation Company, a Delaware corporation releases and quitclaims to OLIVER R. SPIRES and DIANNE E. SPIRES, husband and wife as joint tenants with rights of survivorship, their heirs and assigns forever, all right, title and interest in and to the real property (hereinafter the "Property") situated in Klamath Falls, Klamath County, State of Oregon, as more particularly described in Exhibit A, hereto attached and hereby made a part hereof.

Grantor reserves all income (including, without limitation, rentals, license fees and royalties from any license and other rights to use the Property) granted by Grantor or Grantor's predecessors in interest. Grantees agree that if Grantees receives any such income, Grantees will promptly forward the income to Grantor.

EXCEPTING from this quitclaim and RESERVING unto Grantor, its successors and assigns, forever, all minerals and all mineral rights of every kind and character now known to exist or hereafter discovered underlying the Property, including without limiting the generality of the foregoing, oil and gas and rights thereto, together with the sole, exclusive and perpetual right to explore for, remove and dispose of said minerals by any means or methods suitable to the Grantor, its successors and assigns, but without entering upon or using the surface of the Property, and in such manner as not to damage the surface of the Property, or to interfere with the use thereof by the Grantees, their heirs and assigns.

The true and actual consideration for this conveyance is \$22,800.00.



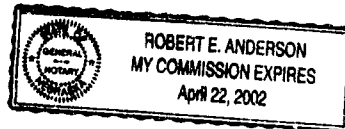
