KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated April 14, 1986, executed and delivered by Donna L. Fensler fka Donna L. 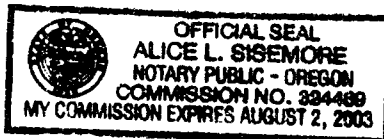
