23. Substitute Trustee. Lender may, from time to time, remove Trustee and appoint a successor trustee to any Trustee appointed hereunder. Without conveyance of the Property, the successor trustee shall succeed to all the title. power and duties conferred upon Trustee herein and by applicable law.

24. Attorneys' Fees. As used in this Security Instrument and in the Note, "attorneys' fees" shall include any attorneys' fees awarded by an appellate court.

25. Insurance Warning. Unless you provide us with evidence of the insurance coverage as required by our contract or loan agreement, we may purchase insurance at your expense to protect our interest. This insurance may, but need not, also protect your interest. If the collateral becomes damaged, the coverage we purchase may not pay any claim you make or any claim made against you. You may later cancel this coverage by providing evidence that you have obtained property coverage elsewhere.

4. INTEREST RATE AND MONTHLY PAYMENT CHANGES

(A) Change Dates

The interest rate I will pay may change on the first day of October , and on that day every sixth month thereafter. Each date on which my interest rate could change is called a "Change Date."

(B) The Index

Beginning with the first Change Date, my interest rate will be based on an Index. This disclosure describes the features of the Adjustable Rate Mortgage (ARM) program for which you have applied. (Information on other ARM programs offered is available upon request. This disclosure does not constitute a commitment by the Lender to make a loan to you. If you eventually obtain a loan from the Lender, the loan Note, Security Instrument and related documents ("loan documents") will establish your legal rights and obligations.

HOW YOUR INTEREST RATE AND PAYMENTS ARE DETERMINED

Your initial interest rate may be a discounted or premium rate. This means that it may be lower or higher than the interest rate which you would have received had your initial interest rate been based on the index plus margin. You should ask us a bout the current margin value and the current interest rate discounts/premiums.

Beginning on the 1st interest rate change date, your interest rate will be determined by adding the current index rate plus the margin and then rounding the sum to the nearest one-eighth of one-percent (0.125%). The most recent index figure available as of the first business day of the month immediately preceding the month in which the change date occurs is called the 'current index". The "Index" is the average of interbank offered rates for six-month U.S. dollar-denominated deposits in the London Market ("LIBOR") as published in the <u>Wall Street Journal</u>. If for any reason this index is not available, the Lender will use a comparable figure. The Lender will give you notice of this choice.

Your interest rate will equal the sum of the index rate plus the margin rounded to the nearest one-eighth of one-percent ((.125%) unless your interest rate "caps" limit the amount of change in the interest rate. Please note that because your initial interest rate may be discounted, your interest rate may increase on the first interest rate change date even if the index decreases. At k about our current interest rate.

Your monthly (principal and interest) payment will be based on the interest rate, loan balance, and loan term.

HOW YOUR INTEREST RATE CAN CHANGE

Your initial interest rate may change on the due date of your twenty-fourth regularly scheduled monthly payment and every six months thereafter.

On the first change date your interest rate may increase up to but not more than 3.00%. On each subsequent change date your interest rate cannot increase or decrease by more than 1.00% from the interest rate in effect prior to the change date. In addition, your interest rate cannot increase over the life of the loan by more than a range of 6.00% to 7.00% over your initial interest rate. Your interest rate will never be decreased to a rate less than the initial interest rate stated on your loan Note.

HOW YOUR MONTHLY PAYMENT CAN CHANGE

Your monthly payment can change based on changes in the interest rate. This means that your monthly payment can change every six months on the 1st payment due date following each interest rate change date.

LATE PAYMENT CHARGE

The Lender will impose a late charge for any regularly-scheduled monthly payment of principal and interest not received within 15 days after the date the payment is due. The amount of the late charge will be 6% of the amount of the late payment or the maximum amount permitted by state law, whichever is less. (See your loan Note for your specific Late Charge.) Because the amount of the payment may change, the amount of your late charge may change.

PREPAYMENT

You may or may not be permitted to prepay all or any part of the unpaid loan balance at any time without a penalty depending on the specific terms of your loan Note and/or Addendum. Your right to prepay your loan with or without penalty is not affected by the fact that your interest rate changes from time to time.

DUE ON SALE/ASSUMPTION

If all or any of the property securing your loans is sold or transferred (or if beneficial interest in the borrower is sold or transferred and the borrower is not a natural person) without the Lender's prior written consent, the Lender may, at its option, tequire immediate payment in full of your loan. If the indebtedness is not repaid upon demand, the Lender may foreclose and seli the property securing your loan.
