REQUEST: Variance 15-99 to vary required side setback from 25 feet to 6 feet to allow

placement of an ATM machine on the west side of the property.

NARRATIVE AND RECOMMENDATION:

A Variance shall be granted only upon finding by the review authority that it satisfies the following criteria:

- A. That the literal enforcement of this Code would result in practical difficulty or unnecessary hardship to the owner. The difficulty or hardship may arise from the property's size, shape or topography, or from the location of lawfully existing buildings or improvements.
- B. That the condition causing the difficulty was not created by the applicant.
- C. That the granting of the Variance will not be detrimental to the public health, safety and to the use and enjoyment of adjacent properties and will not be contrary to the intent of this Code.

The applicant requests approval for variance to the required setbacks to allow an automatic teller machine to be located on the west side of the BP Gas Station facility. The need for the ATM at this location is for better visibility and access from traffic on South Sixth Street and Madison Avenue. Also, the proposed location will avoid conflict with traffic flow and movement of semi trucks and other large vehicles moving in and out of the gas card lock system behind the mini mart. The proposed location of the ATM will not cause a visual obstruction to traffic on South Sixth Street or Madison Avenue. If the ATM were placed on the mini mart building, it would not be as productive/convenient as a drive-up unit.

Notice was sent out to 7 surrounding property owners and to 5 agencies. No negative response was received from any of the contacted parties.

Review of the application does not reveal any detrimental effect to the use and enjoyment of adjacent properties. No negative response has been received to this application.

Staff recommends the Director approve the request conditioned on:

1. Article 41 Site Plan Approval shall be obtained within two years of the date set out below or this approval shall be void.
