KNOW ALL BY THESE PRESENTS that Klamath County, a political sub-division of the State of Oregon

hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Ed Oueilhe & Deborah Lyn Oueilhe, as Tenants by the Entirety

hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Lot 7, Block 30, Tract 1184 - Oregon Shores - Unit 2 - 1st Addition situated in Section 17, Township 35 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon.

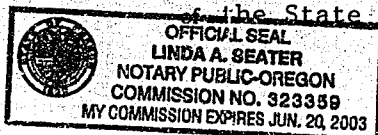
