NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by Larry Allen Brown and Barbara K. In construing this notice, the singular includes the plural, the word "grantor" includes any successor in interest to the grantor as well as any other person owing an obligation, the performance of which is secured by said trust deed, and the words "trustee" and "beneficiary" include their respective successors in interest, if any.



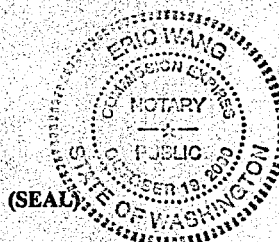
