
The remaining property described in the trust deed shall continue to be held by the trustee under the terms of the trust deed. This par-

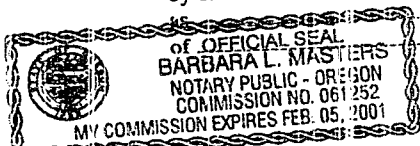


