

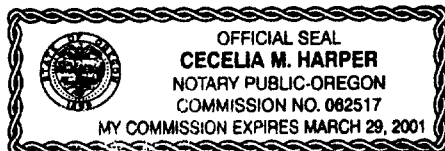

The trust deed was dated April 30, 1998, and recorded May 4, 1998, in the microfilm Records of that county, in Volume M98 at page 14898. Thereafter, a Notice of Default with respect to the trust deed was recorded on July 12, 1999 in the microfilm Records of said county, in Volume M99, at page 27838. Thereafter, the trust deed was duly foreclosed by advertisement and sale, and the real property covered by the trust deed was sold at the trustee's sale on January 10, 2000. I reasonably believe that, at no time during the period of three months and one day immediately preceding the date of the sale, and including the day thereof, was the real property described in and covered by the trust deed, or any interest therein, owned by a person in the military service as defined in Article I of the "Soldiers' and Sailors' Civil Relief Act of 1940," as amended.
